### IV. RECOMMENDATION ON DRAFT FFY 23-26 TRANSPORTATION IMPROVEMENT PROGRAM (TIP)

Kyle Thompson began the discussion by explaining what the Transportation Improvement Program is. He noted for projects to receive Federal funding they must be listed in the Ames Area MPO Transportation Improvement Program. A new Transportation Improvement Program is created annually. The MPO evaluates regional applications to award funding for STBG & TAP programs. Mr. Thompson said more information on the programs is available on the Iowa DOT website, as well as in the TIP document.

Mr. Thompson said there were two STBG applications this year. One application was from the City of Ames for Bloomington Road Pavement Improvements (GW Carver-Eisenhower). The second application was from CyRide for Vehicle Replacement. One TAP application was received from the City of Ames for S Dayton Avenue Path (Isaac Newton Drive-E Lincoln Way). He said it is the staff recommendation that the full amount requested be awarded for each of the applications received. He displayed a map on the screen of all the current STBG funded projects.

Kelly Diekmann asked if the projects displayed on the screen are all road projects. Mr. Thompson confirmed that was correct. He said some projects, such as CyRide Vehicle Replacement, are not on the map since they do not have a physical location for the project.

MOTION: (Peterson/Lawrence) Recommend the Draft FFY 2023-2023 Transportation Improvement Program to the Transportation Policy Committee for formal approval.
